Energy Restructuring in Pennsylvania

Bob Bennett, Energy Advisor to the Commissioner of the Pennsylvania Public Utility Commission, will be one of our guest speakers at the May 8th meeting. He will be discussing the planned rate cap removal by 2010 and what the Public Utility Commission is doing to mitigate price increases. Power and Heat

Power and Heat. Using both maximizes efficiency and minimizes your facility's energy bills. Microturbine systems conserve energy and cut operational costs by creating two forms of energy: electricity and heat. Using both energy outputs is called cogeneration or CHP: combined heat and power. Onsite CHP is far more fuel efficient and environmentally beneficial than utility power and boiler heating. The grid-parallel electricity produced lowers a facility's demand on utility power and dramatically cuts monthly power bills. The heat can be used for water/space heating and/or process heating or drying. This offsets fuel consumed by less efficient boilers or heaters.

The heat output of microturbines can be used to both heat and air condition your facility via absorption cooling. In summer months, your energy bills can more than triple due to higher peak power rates and increased power usage due to air conditioning. But your microturbine systems can optionally chill water or water/glycol with absorption coolers, which use heat energy, instead of electric energy, to create air conditioning.

MicroTurbines also act as standby emergency generators. They can operate connected to a utility grid or provide stand-alone power to critical loads. Transition time between these two operating modes is less than 10 seconds, allowing customers to secure their critical power needs.

Directions to the Masonic Village

**Masonic Village at Elizabethtown
One Masonic Drive
Elizabethtown, PA 17022**

Construction Detours: *Due to construction, Bainbridge Road, which runs along the western boundaries of the Masonic Village property, will be closed from the railroad underpass to Poplar Street. A bypass road is expected to be completed by December 2007 at the earliest. These directions have been modified to provide the most convenient and direct routes around the construction.*

From the North: Take I-83 South to I-283 South. Take the last exit off this road before entering the Turnpike, onto Route 283 East toward Lancaster. Travel east on Route 283 for approximately 18 miles to the Elizabethtown/Hershey exit. Take Route 743 South. Turn left onto Route 230. Turn right onto High Street. Continue one mile, pass under the railroad bridge, turn left onto Masonic Drive. Continue to the Masonic Village entrance and follow directional signs.

From Hershey: Take Route 743 South. Turn left onto Route 230. Turn right onto High Street. Continue one mile, pass under the railroad bridge, turn left onto Masonic Drive. Continue to the Masonic Village entrance and follow directional signs.

From the PA Turnpike Traveling East: Take Exit 19/247. Follow Route 283 East to the Elizabethtown/Hershey exit. Take Route 743 South. Turn left onto Route 230. Turn right onto High Street. Continue one mile, pass under the railroad bridge, turn left onto Masonic Drive. Continue to the Masonic Village entrance and follow directional signs.

From the PA Turnpike Traveling West: Take Exit 21/286. Follow Route 222 South to Route 30 West. Follow signs onto Route 283 West and continue to the Elizabethtown/Rheems exit. Turn left onto Cloverleaf Road. Turn right onto Route 230. Turn left onto High Street. Continue one mile, pass under the railroad bridge, turn left onto Masonic Drive. Continue to the Masonic Village entrance and follow directional signs.

From Lancaster: Take Route 283 West to the Elizabethtown/Rheems exit. Turn left onto Cloverleaf Road. Turn right onto Route 230 West. Turn left onto High Street. Continue one mile, pass under the railroad bridge, turn left onto Masonic Drive. Continue to the Masonic Village entrance and follow directional signs.

From York: Take Route 30 East to the Columbia exit. Take Route 441 North to Bainbridge. Turn right onto Route 241. After approximately five miles, turn left onto Masonic Drive. Continue to the Masonic Village entrance and follow directional signs.
