About the Speaker

Richard Illig has served Pennsylvania businesses for 20 years and currently works as a Program Specialist in the Pennsylvania Office of Energy & Technology Deployment at the DEP Central Office in Harrisburg. His primary duties include Solid Waste Management Program liaison, state energy office contact to the U.S. DOE Industrial Technology Program, and coordinator for regional technical assistance services including EPA's Pollution Prevention and Sustainability Program. Ric also maintains Pennsylvania's database of landfill methane resources and helps to evaluate and monitor grant program applications and projects.

Ric began as a Solid Waste Specialist in DEP's Southeast Region by conducting inspections and complaint investigations. These involved hazardous waste management and municipal waste facilities including landfills, transfer stations, infectious wastes and incinerators, and the land application of biosolids. Ric also served on the regional Emergency Response Team prior to transferring to DEP's Williamsport Regional Office.

In Northcentral PA, Ric served as Residual Waste Coordinator covering a 14-county area. Familiarity with regional industry and waste reduction initiatives led to his becoming Assistant to the regional Pollution Prevention Manager in 1996. Through 2004, Ric worked for the Office of Pollution Prevention & Compliance Assistance – now, Office of Energy & Technology Deployment – managing field operations and developing program infrastructure. Ric has conducted over 200 non-regulatory waste reduction-energy efficiency site assessments and has organized multiple seminars advancing waste reduction, energy efficiency, and compliance assistance initiatives. Ric also adopted duties as the Regional Resource Recovery & Recycling Coordinator prior to moving to Harrisburg.

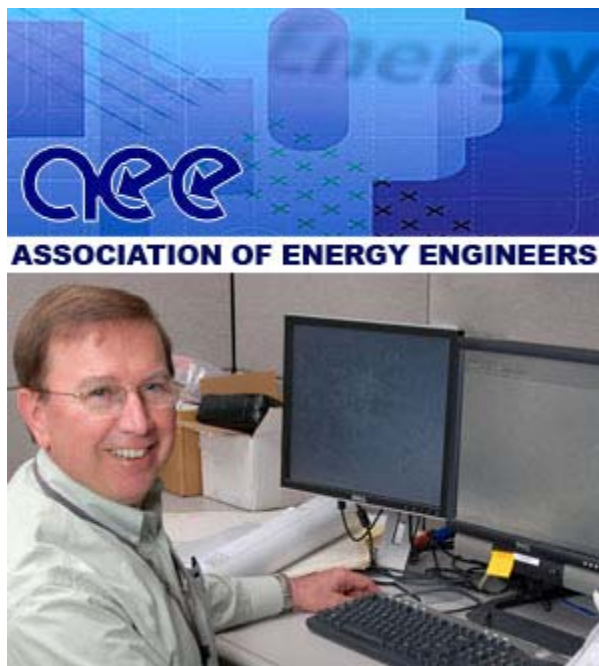

Dave Eberly – 2008 Energy Engineer of the Year



David A. Eberly, Armstrong's principal engineer, has been named a regional Energy Engineer of the Year by the Association of Energy Engineers. Representing Region I of the association, which covers the northeast states, Dave will receive the honor at the World Energy Engineering Congress, Washington, D.C., in October.

During his 34 years at Armstrong, Dave has directed numerous energy efficiency projects, but two efforts in particular triggered his nomination for Energy Engineer of the Year. He successfully achieved the Energy Star designation for our headquarters, Building 701, both in 2006. In September 2008, Building 701 qualified for the Energy Star designation for a second time with a much improved score. He led the effort to secure the energy credits required for that building to be the first in Pennsylvania to receive the US Green Building Council's highest certification.

Dave's work to improve Building 701's energy use was the catalyst for some significant environmental efforts that have made a real difference on the corporate campus. These include:

- Achieving \$25,000 savings in energy costs annually;
 - Attaining a 60% recycling rate;
 - Implementing green cleaning techniques for all campus buildings that saves \$4,000 per year and promotes improved indoor air quality;
 - Installing water saving appliances that save 380,000 gallons of water per year;
- Establishing continual carbon dioxide monitoring to assure adequate airflow in occupied building areas.

According to **Jim Baker**, Director, Facilities Management, Dave plays a key role in our goal to reduce our overall environmental footprint by helping to establish, implement and monitor Armstrong's Corporate Sustainability Initiatives which affect our entire corporation.

Dave is a licensed Professional Engineer, Certified Energy Manager, Green Building Engineer and Certified Sustainable Development Professional. A life member of the Association of Energy Engineers and vice president and a founding member of the Central Pennsylvania Chapter of the association, he shares his expertise in energy efficiency through presentations at industry functions, hosting tours of Armstrong facilities, and publishing and presenting technical papers.
